**STATE OF EMERGENCY:** valid from 05. 10. 2020 until 14. 2. 2021 and other measures and restrictions are applicable. **There is entry ban for foreign nationals in line with the Crisis Measure No. 79 of 28<sup>th</sup> January 2021 restricting free movement with the exception of essential travel.**


- Self-isolation or quarantine do not replace the obligation to undergo a test in the Czech territory.
- Third countries, which are not categorised as green countries, are automatically considered to be dark red countries.
